

## Statement of identification according to 97/129/EC for transport and product packaging materials used in deliveries for UPM Raflatac shipments in EMEIA region\*

The identification of packaging materials laid out in [97/129/EC](#) (the European Union's Commission Decision of 28 January 1997 pursuant to European Parliament and Council Directive [94/62/EC](#) on packaging and packaging waste) is currently voluntary in the European Union (EU). From January 1, 2023, with Italian Legislative Decree 116 of September 3, 2020, the identification of packaging material entering the Italian market becomes mandatory in business-to-business transactions.

For all transport and product packaging used in UPM Raflatac deliveries, please find here the materials classified according to 97/129/EC given in **bold**:

- Reel cores: **PAP 20**
- All wrapping films (e.g., coil, stack, pallet wrapping): **LDPE 4**  
*(The pallet labels alone are PAP 22 but make up less than 5% of labelled film + label.)*

Packaging materials always included in transport packaging are pallets. Depending on whether you receive wooden or plastic pallets, the following codes apply:

- a) Pallets made from wood: **FOR 50**
- b) Pallets made from plastic: **PP 5**

Packaging materials optionally included in transport and product packaging are these:

- Lid: **FOR 50**
- End disk: **PAP 20**
- Film sheet pallet cover: **LDPE 4**
- Pallet strapping or other straps: **PET 01**
- Corner protection to protect from straps in plastic: **PET 1**
- Carton/ cardboard protection (on top of pallets): **PAP 20**
- Ream wrapping (only for sheets): **C/PAP 81**
- Carboard boxes (only for sheets and sample materials/ coils): **PAP 20**
- Cover for pallets (only for sheets): **FOR 50**
- Coil wedges (only used if your coils are packed horizontally): **PAP 20**
- Core plugs classified depending on their type:
  - a) Core plugs made from wood: **FOR 50**
  - b) Core plugs made from plastic: **PP 5**
- Coil interleaving classified depending on their type:
  - a) Interleaving made from paper: **PAP 22**
  - b) Interleaving made from film: **HDPE 2**

## Dichiarazione di identificazione ai sensi della direttiva 97/129/CE per i materiali di trasporto e di imballaggio dei prodotti utilizzati nelle spedizioni di UPM Raflatac nella regione EMEIA\*

L'identificazione dei materiali di imballaggio prevista dalla [97/129/CE](#) (la Decisione della Commissione dell'Unione Europea del 28 gennaio 1997 ai sensi della direttiva [94/62/CE](#) del Parlamento e del Consiglio Europeo sugli imballaggi e i rifiuti di imballaggio) è attualmente su base volontaria nell'Unione Europea (UE). Dal 1° gennaio 2023, con il Decreto Legislativo 116 del 3 settembre 2020, l'identificazione del materiale di imballaggio che entra nel mercato italiano diventa obbligatoria nelle transazioni tra imprese.

Per tutti i trasporti e gli imballaggi dei prodotti utilizzati per le spedizioni di UPM Raflatac, elenchiamo di seguito i materiali classificati secondo la direttiva 97/129/CE come indicato in **grassetto**:

- Anima bobine: **PAP 20**
- Tutti i film di avvolgimento (ad es. bobina, pila di bobine e avvolgitura del bancale): **LDPE 4**  
(Le sole etichette per pallet sono PAP 22 ma costituiscono meno del 5% del film etichettato + etichetta.)

- Protezione di cartone (sopra i bancali): **PAP 20**
- Avvolgimento delle risme (solo per i fogli): **C/PAP 81**
- Scatole di cartone (solo per i fogli e per le bobine di campionatura): **PAP 20**
- Coperchi dei bancali (solo per i fogli): **FOR 50**
- Cunei per bobine (utilizzati solo se le bobine sono imballate orizzontalmente): **PAP 20**
- Tappi per mandrini classificati in base alla loro tipologia:
  - a) Tappi in legno: **FOR 50**
  - b) Tappi in plastica: **PP 5**
- Fogli intrabobina classificati in base alla loro tipologia:
  - a) Fogli in carta: **PAP 22**
  - b) Fogli in film: **HDPE 2**
